

## LEWISVILLE PUBLIC ART ADVISORY COMMITTEE MEETING MINUTES

- I. **Call to Order** – Chair Campbell called the meeting to order at 5:00 PM. In attendance were Barbara Campbell, Holli Conger, Thomas Jenkins, Elizabeth Miller, Rebecca Scherbak, Town Manager James Ayers and Town Clerk Dora Moore.
- II. **Agenda Approval** – Holli Conger moved to approve the agenda. Elizabeth Miller seconded the motion and motion passed unanimously.
- III. **Minutes Approval** – Holli Conger moved to approve the July 10, 2023 minutes amended to reflect the meeting was held at 5 PM, the meeting was held at Town Hall and that the call for artists subcommittee would only evaluate MAWCC. Thomas Jenkins seconded the motion and motion passed unanimously.
- IV. **Old Business**
  - A. 2024 Winter Art Show
    1. Date – February 9, 2023, 4:30-7:30 PM at Mary Alice Warren Community Center (MAWCC)
    2. Theme – The committee considered two themes: I Love Lewisville and Lewisville: The Town I Love. ‘Lewisville: The Town I Love’ was selected as the 2024 winter theme.
    3. Call for Artists – Artists can drop off their art at MAWCC on February 7 from 2-7 PM. Drop off by appointment only will be on February 8. The art will be on display from February 9-March 9. Artists will pick up their art on March 11 or by appointment after March 11. Entry deadline will be January 26. The show will be advertised in the Town’s November/December newsletter. Mrs. Conger will develop the newsletter graphic. Mr. Jenkins and Mrs. Scherbak will develop a draft call for artist. The call will be reviewed at the September meeting. The call will be for artists 18 and up but the call will encourage artists to stay tune for a forthcoming youth show.
- V. **New Business**
  - A. MAWCC hanging system and display cases – The current hanging system and display cases were discussed. This is something that will need to be discussed more as the winter show nears. The purchase of clear Plexiglas cubes was discussed as well as the placement of small easels in the display case.
  - B. Long-range planning
    1. MAWCC art – The committee would like to see some permanent art along the gallery wall.
    2. Possible public art locations – This was not discussed.
    3. Inventory of current art – Mrs. Campbell is compiling a list of art and their current location.
    4. Art projects funding – This item will be discussed at the November meeting.
    5. Youth art show – This item will be discussed at the September meeting.
