As described in NC § 160A-360(f): When a city annexes, or a new city is incorporated in, or a city extends its jurisdiction to include, an area that is currently being regulated by the county, the county regulations and powers of enforcement shall remain in effect until (i) the city has adopted such regulations, or (ii) a period of 60 days has elapsed following the annexation, extension or incorporation, whichever is sooner. During this period the city may hold hearings and take any other measures that may be required in order to adopt its regulations for the area.

The zoning district classifications contained in the Zoning Ordinances of Forsyth County and the Town of Lewisville are very similar and the permitted uses and development standards are in most cases equivalent, if not identical. The purpose of this zoning map amendment is to continue a similar type of zoning within the Town of Lewisville as previously applied under Forsyth County jurisdiction.

### **REQUEST**

This text amendment was drafted by staff in response to the request of the Planning Board to remove the allowance of multi-family or institutional uses to located off-site parking on residentially zoned property.

#### BACKGROUND

When the Town of Lewisville took over their own planning jurisdiction, the ordinance adopted by the town was the ordinance already in place by the City-County Planning Department. More recently, the Town defined the boundary of the Downtown Overlay (DTO) recognizing some surrounding vulnerable properties. The permission of multifamily or institutional uses to have off-site accessory parking in a residential district raised many concerns for the Planning Board and area residents.

#### **ANALYSIS**

Currently, the Unified Development Ordinance allows accessory off-site parking to be located on a residentially zoned abutting property for multifamily and institutional uses. This section of the ordinance comes with little regulation on the accessory parking lot. This is only the case for multifamily and institutional uses. If there is a commercial, industrial or other use, the property where the parking lot is to be located has to be in a zoning district where the principle use would already be allowed, not in a residential district. The Planning Board discussed different resolutions of either removing the section all together or by requiring stricter regulations in order for a residential lot to be used for accessory parking.

#### **SUMMARY**

There are two options for the Planning Board to review. One text amendment option will remove the allowance of residential property to be used for off-site accessory parking. The second amendment option gives greater restrictions if the section is to be left in the Ordinance. The exact language to be added and/or amended to the UDO is attached.
